Wineries that wish to participate must have a valid copy of their NYS Sales tax permit along with a copy of their Winery Permit, issued by the NYS Liquor Authority with them the day of the event and be able to present it if asked by a member of the Festivals Fredonia Committee or a Federal/State Government Agency. Winery must provide a valid Certificate of Insurance, naming Festivals Fredonia, Inc. as an additionally insured. Winery vendor is expected to treat customers in a courteous manner. Discrimination of any kind for any reason is NOT permitted. Festivals Fredonia, Inc. reserves the right to void this contract at any time in the event the business/owner named above is found to be in violation of any federal, state or local law.**

**You must provide your own tables, chairs and tents; you will be situated within Barker Commons, along with the Fredonia Farmers' Market, on the West side of the Commons.**

**It is mutually understood and agreed that the above named stands in relationship of an independent contractor to, and is not an employee or agent of the Committee or Festival in question.
